# A Study on the Awareness of Human Rights Education among Higher Secondary Students

## **ABSTRACT**

Human Rights' is one of the most 'talk' of an hour in todays'society. The existence of that right as an "inalienable," universal, right of all people was asserted in the UN General Assembly's Declaration of December 1986.' Unfortunately, that instrument is hardly a model of clarity, and it has generated a large amount of scholarly comment, some of it confusing or skeptical, on whether such a right exists - and if so, what it means. It is of immense concerned whether every human being (male and female) have equal rights or not? Human Right is the right that every human being possessed just because he/she is being born as a human; irrespective of caste, creed, religion, sex, race, nationality or region. Human Rights education implies the learning and practice of human rights or in other words it is said to be educating the people to understand about their birth right. Human rights education in fact is a comprehensive term which includes a lot more than just learning about human rights. Education for human rights also gives people a sense of responsibility for respecting and defending human rights and empowers them, through learned skills, to take appropriate action.

- It is being found that students think that Human Rights Education is important and feel it necessary to share knowledge about Human Rights with others and 91% of the students shared that Human Rights Education produce changes in values and attitudes in us.
- It is also found that students have responded that educational institutions have great role to play to promote Human Rights Education. 40% of the students have Human Rights as a subject and 51% of the students have Human Rights Education in Syllabus.

## III. SUGGESTIONS:

- > Human Rights Education should be made a compulsory subject for all the students in colleges.
- Basics of Human Rights concept should be introduced in the school education itself.
- > Seminars, Discussions, workshops should be conducted frequently to popularize the concept.
