The American Library Association Presidential Committee on information literacy recognized that the "information age is divorced from most teaching styles" (ALA 1989). In its report, the ALA Presidential Committee called for a restructuring of the learning process in order to create new information-age school characterized by interactive, self-initiated learning with the teacher as the guide to learning.

In March, 1998 – the National Forum on Information Literacy (NFIL), a broad based association of over 65 national organizations, issued a report on "Information Literacy" in which they reported on the status of the recommendations of the 1989 report. Recommendation of the Report 1989 stated that "Teacher education and performance expectations should be modified to include information Literacy concerns. Increase in information technology has resulted in the development of new standards, which deal in whole or part with information literacy skills. The International Society for Technology Standards Projects (NETS) has begun a multi-year effort to "effectively support use of technology for teaching-learning and administration" (Thomas, 1998) and also helps to locate, evaluate and collect information from variety of sources.

The Commission on Higher Education of the Middle States Association of Colleges and Schools has been implementing standards for information literacy at the institutional level for some years. The association offers professional development workshops on this topic in conjunction with its national meetings.

Recent studies in cognitive science refute the notion that content comes before process, recognizing that the process of accessing, evaluating and using information is integral to understanding content. The information literate teacher will also be able to select and use resources most appropriate to multiple intelligences and learning styles.

# AIMS OF INFORMATION LITERACY:

- The ability to process of intellectual access includes the development of a strategy for locating information connected with latest information about the teaching methods.
- Providing access to and using resource based learning experience in the education field.
- The information-literate student/faculty will also be able to select and use resources most appropriate to multiple intelligences and learning styles.
